Discussion Items:	Action Items and notes:
Welcome	Johan welcomes the participants and asks if anyone has any objection to this meeting being recorded. There is no objection.
Approval of the minutes	The minutes of the meeting of the 19 th of January 2023 are approved and will be published on the website.
Review Anti-doping document	Johan introduces Jeanne Courbe, World Triathlon Anti-doping manager, who is here to present a new Anti-doping document to the LCC. In 2022, Jeanne had to fill in the Code Compliance Questionnaire coming from WADA. This questionnaire was mandatory for all the WADA Code signatory to make sure the rules are well implemented. After reviewing it, WADA asked

World Triathlon to improve its compliance with the GDPR by creating a document to explain how, for every Anti-doping activity, the data are collected, processed, kept...

LCC members are going to review and share their comments before the 3rd of March 2023. The Members raise that they are not specialized in GDPR, they will give their opinion and comments based on their knowledge.

Jeanne leaves the meeting after presenting the document and responding to the participants questions.

Tribunal rules

The Tribunal Procedural Rules were shared with the participants today. The rules and going to be reviewed and discussed during the next LCC meeting.

EB power in exceptional circumstances

Exchange on how the "exceptional circumstances" should be defined to avoid any abuse of power.

Update the rules of the Congress Procedure

The new rules should be ready in 2023.

Determining the order of the criteria provided for elections (gender, CC, other)

It was not clear which criteria should be taken first, rules should be established on that regard. The rules need to be clear for the 2024 election. It will be discussed during the next LCC meeting.

Definition of multisport and proposal to delete article 47c

There should be a clear definition for "Multisport". It should be in the definitions part at the beginning of the Constitution, not in the middle of it.

Check if the version that was updated is on the World Triathlon website.
