Indeed, last year we saw staff salaries increase by 4.00%, which was entirely reasonable due to the inflationary pressures, and we would expect this to continue in the short term. 	We are also concerned that with the existing uncertainty in the world's investment markets, this too could lead to a lower return being available for TRI, as was the case in 2022, when we recorded a year-end loss of -\$422,474.00 and more reliance on increasing the contribution from the IOC funding to balance the budget, as we can see in the 2024 proposed budget. Whilst the loss is strictly a Balance Sheet item, under Swiss law and accounting principles require this to be shown as a Profit & Loss line item and the ensuing loss recorded for 2022 was solely down to the reduction in the investment portfolio value. The combination of these factors could have a significant effect on the Profit & Loss Accounts as well as the Balance Sheet for the current in-year budget 2023 and as such the base assumptions used for the 2024 budget could be wide of the mark and lead to a significant variance in the actual outcome vs. the budget, that we are seeking approval from Congress in September 2023.
