CHARTER of UZBEKISTAN TRIATHLON FEDERATION

1. GENERAL PROVISIONS

- 1.1. UZBEKISTAN TRIATHLON FEDERATION (hereinafter referred to as the Federation) is a non-governmental non-profit organization in the organizational and legal form a public association created on a voluntary basis by individuals in order to develop triathlon, as well as other triathlon-related sports (multi-sport) aquathlon, duathlon, intercity triathlon, winter triathlon, indoor triathlon, including paratriathlon (hereinafter referred to as triathlon), to represent the triathlon of Uzbekistan in the International Triathlon Union (ITU), the World Triathlon Corporation (WTC), the Asian Triathlon Confederation (ATC) and other international organizations .
- 1.2. The Federation, which is a member of the ITU, undertakes to comply with the provisions of the National Olympic Committee of Uzbekistan, guided by the Olympic Movement, the International Olympic Charter and the World Anti-Doping Code. The Federation, in accordance with the direction of activity and goals at the national level, participates in activities to support the Olympic Movement. The Federation undertakes to promote sports ethics, support and stimulate the anti-doping fight.
- 1.3. The federation recognizes that the ITU is the world-class international organization governing triathlon.
- 1.4. From the moment of state registration of the Federation in the manner prescribed by the legislation of the Republic of Uzbekistan, it acquires the status of a legal entity.
 - 1.5. The duration of the Federation is not limited.
- 1.6. The Federation closely cooperates with state bodies, enterprises, institutions, non-profit organizations whose activities are aimed at the development and stimulation of triathlon in the Republic of Uzbekistan in the manner prescribed by law.
- 1.7. From the moment of state registration, the Federation becomes a legal entity and acquires all the rights of a legal entity. The Federation concludes transactions on its own behalf, acquires property and personal non-property rights, bears obligations, has the right to act as a plaintiff and a defendant in court. It has bank settlement accounts on the territory of the Republic of Uzbekistan and abroad, has an independent balance sheet, seal, stamps and company name.
- 1.8. The Federation contributes to the development of triathlon as an Olympic sport at the level of the Republic of Uzbekistan and at the world level.
- 1.9. The Federation carries out its activities in the Republic of Uzbekistan and foreign countries in the prescribed manner.
- 1.10. The Federation voluntarily, in accordance with international treaties, has the right to enter into unions and associations, international relations and relations.
- 1.11. The Federation does not interfere in the activities of state bodies and officials of the Republic of Uzbekistan, other registered public associations, does not pursue commercial and political goals.
 - 1.12. The Federation operates on the basis of the following principles:
 - 1) voluntariness, equality of its members, self-government, legality, accountability and publicity;
 - 2) the unity of the Federation and the independence of members in solving statutory tasks:
 - 3) participation in the election of the supreme body of the Federation;
 - 4) obligatory execution of decisions of the highest bodies of the Federation for grassroots bodies;

- 5) consistency in the work and responsibility of each member in the performance of duties and tasks.
- 1.13. The Federation is responsible for all property that can be levied in accordance with the current legislation of the Republic of Uzbekistan. Members and founders of the Federation are not liable for the obligations of the Federation, just as the Federation is not liable for the obligations of its members and founders.
- 1.14. The Federation does not allow discrimination against members or persons of the Olympic Movement (competitors, officials, judges, delegates, coaches and other persons) based on their race, gender, religion or political beliefs.
- 1.15. In its activities, the Federation promotes gender equality, ensures the presence of female representatives, strives to ensure the presence of at least 20 percent of females in meetings and branches.
- 1.16. The Federation has a registered emblem, seals, forms, stamps indicating its company name in Uzbek, Russian and English, its own property, as well as other means of individualization.

2. NAME, GOALS AND TASKS OF THE FEDERATION

2.1. Name of Federation:

in Russian - ФЕДЕРАЦИЯ ТРИАТЛОНА УЗБЕКИСТАНА;

in Uzbek - O'ZBEKISTON TRIATLON FEDERATSIYASI;

in English - UZBEKISTAN TRIATHLON FEDERATION.

2.2. Abbreviated name of the Federation:

in Russian - ΦΤУ;

in Uzbek - ЎΤΦ or O'TF;

in English - UTF.

- 2.3. Permanent location of the Federation shall be at No. 6, Almazar Str., Almazar District, Tashkent City, Republic of Uzbekistan.
 - 2.4. The main goals of the Federation are:
- 1) Joint training, assistance in the prescribed manner to ensure the participation of the national triathlon team of the Republic of Uzbekistan, formed by the Ministry of Physical Culture and Sports of the Republic of Uzbekistan, in the Asian Championship, Asian, Olympic and other international and national competitions;
- 2) Assist the NOC in developing, in the prescribed manner, selection criteria for representing the national triathlon team of the Republic of Uzbekistan at the international level;
- 3) Organization of training courses in accordance with national and international standards for coaches, athletes, triathlon officials, as well as the ethics of multisport, including paratriathlon;
 - 4) Attracting the broad masses of the population to active triathlon classes;
 - 5) Training of qualified personnel in triathlon;
- 6) Establishment and development of international relations with international federations and organizations of other countries, aimed at the development of triathlon;
- 7) Carry out activities in other areas that contribute to the development of triathlon in the Republic of Uzbekistan, in accordance with the charter;
 - 8) Creation and strengthening of the material and technical base of the Federation.
 - 2.5. Federation tasks:
 - 1) Contribute to strengthening the unity and integrity of the Olympic Movement;

- 2) Strengthening the position and increasing the reputation of Uzbek sports in the international arena;
 - 3) Protecting the health of athletes, fighting for fair sport without doping and drugs;
- 4) Involvement in participation in the triathlon of all classes of citizens of the Republic of Uzbekistan, foreign citizens, stateless persons legally located on the territory of the Republic of Uzbekistan, regardless of their age, gender and race;
- 5) Development of sports relations with international federations and international sports organizations, ITU, WTC, ATC;
- 6) Development and promotion of triathlon in all areas on the territory of the Republic of Uzbekistan;
- 7) Adoption of uniform rules and standards for selection in agreement with the Ministry of Physical Culture and Sports of the Republic of Uzbekistan;
- 8) Organization and holding of championships or other competitions of the Federation at the international, republican, regional, city levels;
- 9) Organization and holding of international championships-competitions in triathlon in agreement with international sports organizations, including ITU, WTC, ATC and the Ministry of Physical Culture and Sports of the Republic of Uzbekistan (hereinafter referred to as the Authorized Body);
- 10) The desire to improve the quality of sports facilities for triathlon in the Republic of Uzbekistan;
- 11) Registration and confirmation of triathlon records of its members in the Republic of Uzbekistan;
- 12) Submission to international sports organizations of materials to confirm the records set by their members;
- 13) Assistance in conducting doping control in national championships and assisting ITU, WTC in conducting doping control out of competition.
- 2.6. The governing body of the Federation is authorized to use the rights provided by the legislation to achieve the goals of the development of triathlon in the Republic of Uzbekistan.
- 2.7. The goals and objectives of sports clubs and other organizations in the field of triathlon, intending, together with the Federation, to enter the system of competitions organized by the Federation, must comply with the goals and objectives of the Federation.
- 2.8. The federation assists organizations and clubs in the field of triathlon in the development of programs for professional and non-professional athletes in all disciplines.
- 2.9. Sports clubs and other organizations in the field of triathlon, which are part of the structure of the Federation, are required to comply with the provisions of internal documents, the charter and rules of the Federation.
- 2.10. The Federation carries out relations with sports clubs and other organizations in the field of triathlon on the basis of agreements.
- 2.11. The Federation carries out its activities at the level of the Republic of Uzbekistan and at the international level.

3. RIGHTS AND DUTIES OF THE FEDERATION

3.1. Federation's rights shall be to:

- 1) disseminate information within the framework of their activities in the prescribed manner, protect the legitimate interests of members of the Federations in public and other organizations of the Republic of Uzbekistan;
- 2) enter into legal relations with public associations and other legal entities and individuals of the Republic of Uzbekistan in the manner prescribed by law;
- 3) provide a representative of the NOC of the Republic of Uzbekistan with access to participate in meetings of the governing bodies of the Federation as an observer, upon agreement with the NOC;
- 4) open bank accounts in banks of the Republic of Uzbekistan in accordance with the current legislation;
- 5) have a seal, stamps, forms, symbols that do not contradict the legislation of the Republic of Uzbekistan;
 - 6) create working groups and bodies within the Federation;
- 7) organize and hold interregional, international sports competitions in triathlon, develop and approve regulations on such events;
- 8) hold professional and amateur sports competitions between men's, women's, children's and youth and student teams;
- 9) hold exhibitions, reviews, sports competitions and other cultural and educational events that do not contradict the legitimate goals and objectives of the Federation;
- 10) develop, use, dispose, i.e. own all rights in relation to the emblem of the triathlon team, in the form of official, souvenirs and prize attributes;
- 11) promote the formation of national teams of the Republic of Uzbekistan for the preparation and participation in national and international competitions;
- 12) form, on the basis of agreements, teams of coaches, scientific, medical specialists, as well as other specialists to prepare sports teams of the Republic of Uzbekistan for participation in international sporting events;
- 13) carry out attestation of coaches, sports referees and other specialists of the Federation and monitor their activities;
- 14) approve the official uniforms and equipment of the Federation, as well as for participation in competitions;
- 15) implement the statutory goals and objectives of the Federation, including participating in official international events of sports teams of the Republic of Uzbekistan in the prescribed manner;

hold physical culture and sports events, receive funds, including state assistance, in the prescribed manner, to support triathlon fans;

- 16) enter into civil law transactions;
- 17) maintain international relations, conclude relevant agreements, with the exception of religious organizations, participate as a collective member of international non-governmental non-profit organizations;
- 18) create in foreign countries its structural subdivisions (branches and representative offices) on the basis of generally accepted norms and principles of international law, international treaties and the legislation of the respective countries;
 - 19) hold meetings with sports veterans;
- 20) establish mass media, carry out publishing, advertising, information activities, participate in television and radio programs related to the activities of the Federation, prepare triathlon training programs;

- 21) acquire and use property and personal non-property rights;
- 22) create other legal entities, unless otherwise provided by law;
- 23) participate in the activities of members of the Federation within the framework of the powers provided for by this Charter;
 - 24) spend funds to achieve statutory goals;
- 25) send employees and members of the Federation on local and foreign business trips, meet foreign groups and delegates, and participate in other activities that do not contradict the legislation and international obligations of the Republic of Uzbekistan;
 - 26) attract foreign and local investments for the development of triathlon;
 - 27) determine unified systems and regulations for organizing the activities of its members;
- 28) centrally manage the educational processes of regional and city national triathlon teams of the Federation;
- 29) finance independently or jointly regional, national and international sports competitions or training camps for sports, national teams;
- 30) provide methodological and financial assistance to individuals and organizations in accordance with the charter;
- 31) determine the date and place of holding all national championships and other events related to the powers of the Federation;
 - 32) exercise other rights within the framework of the status of the Federation.
 - 3.2. Federation's duties shall be to:
- 1) really and for a long time engage in sports activities, be a member of the ITU, fully complying with the Olympic Charter, recognized by the IOC;
 - 2) be responsible for the actions of members of the delegation of the Federation;
- 3) work closely with the state bodies of the Republic of Uzbekistan, develop appropriate relationships;
- 4) cooperate with the National Olympic Committee of Uzbekistan in promoting the basic principles and values of the Olympic Games;
- 5) timely pay membership fees and other payments to organizations in which he is a member;
- 6) prepare, form, approve members of national sports teams in sports, together with local sports federations, central and local authorities, ensure their participation in the Olympic Games, Youth Olympic Games and other complex international sports competitions;
- 7) participate in the implementation of programs for the development of physical culture and sports related to the powers of the NOC;
- 8) notify the Ministry of Justice of the Republic of Uzbekistan about changes in the location of the leadership of the Federation, legal address, permanent governing body, as well as in information about leaders and other changes;
- 9) send to the NOC of the Republic of Uzbekistan the texts of amendments and additions made to the constituent documents of the Federation, subject to consideration jointly with the relevant international federation on the basis of the relevant provisions and current regulations;
- 10) be responsible for activities that are contrary to the legislation of the Republic of Uzbekistan;
- 11) provide a representative of the NOC with access to participate in meetings of the governing bodies of the Federation as an observer in agreement with the NOC;

- 12) carry out other duties in accordance with the legislation of the Republic of Uzbekistan, the Olympic Charter of the International Olympic Committee, this charter and its requirements;
- 13) comply with and be guided by the mandates and regulations of the World Anti-Doping Agency and the National Authority against Drug Abuse in Sport, coordinate programs and activities aimed at eliminating the illegal use of psychotropic substances and the abuse of illegal substances, and to achieve the absence of doping in sport.

4. MEMBERS AND GOVERNING BODIES OF THE FEDERATION

4.1. Membership of the Federation is accepted, regardless of race and gender, persons residing on the territory of the Republic of Uzbekistan and over 18 years old, by decision of the Secretary General of the Uzbekistan Triathlon Federation on the basis of their written application.

Citizens of the Republic of Uzbekistan, foreign citizens, stateless persons who recognize and respect this Charter can be members of the Federation, the rights and interests of all members are protected equally.

Voluntary withdrawal from the membership of the Federation is carried out by decision of the Secretary General of the Uzbekistan Triathlon Federation of the Secretary General of the Uzbekistan Triathlon Federation on the basis of a written application of the withdrawing member.

4.2. In case of gross violation by members of the legislation or the provisions of the charter, they may be excluded from the membership of the Federation by decision of the Secretary General of the Triathlon Federation of Uzbekistan.

4.3. Rights of the Federation members shall be to:

- participate in the events of the Federation;
- use the property of the Federation in the manner prescribed by the governing body of the Federation;
- apply to the governing body of the Federation with a complaint in case of disagreement with their forced exclusion from membership;
 - voluntarily withdraw from membership;
 - have other rights provided for by law.

4.6. Duties of Federation Members shall be to:

- comply with the requirements of the constituent documents and this charter, fulfill the assigned duties;
 - comprehensively promote the implementation of the activities of the Federation;
 - actively participate in exhibitions and events held by the Federation.

GOVERNING BODIES

- 4.7. The governing bodies of the Federation are:
- Conference;
- Chairman of the Federation.

The Chairman of the Federation is elected by the Conference for a term of 5 years.

To exercise control over the financial and economic activities of the Federation, a Control and Auditing Commission is created.

4.8. **The Conference** of the Federation is the highest governing body of the Federation, it is convened as needed, but at least once every five years. The Conference consists of members of the Federation or delegates of the members of the Federation, elected from among the members of the Federation. The quota and number of delegates is determined by the body convening the Conference.

The Conference may be convened at the initiative of the Chairman of the Conference or the Control and Audit Commission.

The meeting of the governing bodies of the Federation is competent if it is attended by two thirds of the total number of persons who must participate in it, the decision of the governing bodies is taken by a two-thirds majority of the total number of votes of the participants in the meeting.

- 4.9. The powers of the Conference include:
- introduction of amendments and additions to the charter, approval of the charter in a new edition;
 - election of the Chairman of the Federation for a period of 5 years and his dismissal;
 - making a decision on the reorganization and liquidation of the Federation;
 - determination of entrance and membership fees of the Federation;
 - hearing and acceptance of the report of the Chairman of the Federation;
- election of the Control and Audit Commission for a period of 5 years and the adoption of its report;
 - determination of the strategic tasks of the Federation;
- solution of other issues that do not contradict the legislation of the Republic of Uzbekistan
 and international acts adopted in Uzbekistan, in accordance with the charter.
- 4.10. Questions related to the powers of the Conference cannot be transferred or transferred to another body of the Federation.
 - 4.11. The Control and Audit Commission of the Uzbekistan Triathlon Federation:

Control over the financial and economic activities of the Triathlon Federation of Uzbekistan, the targeted use of funds is carried out by the Control and Audit Commission, elected by the Conference consisting of 3 people for a period of 5 years.

The Chairman and members of the Control and Audit Commission cannot participate in other activities of the Triathlon Federation of Uzbekistan, and be part of the governing bodies and leadership of the Federation.

The Control and Audit Commission at least once a year carries out a scheduled audit, and by decision of the Conference, an unscheduled audit.

The Control and Audit Commission carries out its activities on the basis of the current regulatory legal acts and this charter.

Reports on the activities of the Control and Audit Commission are considered and approved at the Conference.

- 4.12. The Chairman of the Uzbekistan Triathlon Federation is elected by the Conference for a period of 5 years.
 - 4.13. The Chairman of the Uzbekistan Triathlon Federation has the following powers:
 - to manage the activities of the Federation on a voluntary basis;
 - make decisions on the management of the Federation within its powers;
- participate on behalf of the Federation at conferences, symposiums, congresses and other events;
 - The chairman of the Federation may have other powers.
- 4.14. The duties of the Chairman of the Federation may be carried out on his instructions by one of the Deputy Chairman of the Federation, appointed to the position and dismissed by the Chairman of the Federation.
- 4.15. The First Deputy and Deputy Chairmen of the Federation are appointed and dismissed by the Chairperson of the Federation and are accountable to the Chairperson of the Federation. The

first deputy and deputy chairmen of the Federation are vested with the appropriate powers, rights and duties by the decision of the chairman of the Federation.

- 4.16. A person who is or is not a member of the Federation may be elected by the Conference to the position of the Honorary Chairman of the Federation for a period of 5 years, who carries out his activities on a voluntary basis.
- 4.17. The Honorary Chairman of the Federation, as an exception, by decision of the Chairman of the Federation, may represent the interests of the Federation in international organizations and international, Olympic and other events.
- 4.18. The Secretary General of the Federation directs the current activities of the Federation, with the exception of resolving issues related to the powers of the supreme governing body of the Federation.
- 4.19. The Secretary General of the Federation is appointed to the position for a period of 4 years and dismissed by the Chairman of the Federation.
- 4.20. Along with the implementation of decisions of the highest governing body of the Federation, the powers of the Secretary General include:
- 1) act without a power of attorney on behalf of the Federation, represent its interests in relations with state bodies, legal entities and individuals, other organizations and enterprises;
- 2) issue powers of attorney within their powers to act on behalf of the Federation, including the representation of their powers;
 - 3) prepare and submit to the Conference for approval of financial statements;
- 4) send to the members of the Federation at the e-mail addresses indicated by them notifications about the Conference;
- 5) hire, transfer to another position, dismiss employees of the Federation, within the approved cost estimate, apply incentive measures to them and impose disciplinary sanctions, determine wages and salaries of employees in accordance with the staffing table of the Federation;
- 6) coordinate the activities and work of the territorial divisions and representative offices of the Federation, employees, working groups, commissions of the Federation;
 - 7) provide material and technical support for the activities of the Federation;
- 8) attract additional sources of financial and material resources for the implementation of legal activities;
 - 9) open settlement accounts in banks, manage them, dispose of the funds on the account;
- 10) organize meetings of the governing bodies of the Federation, keeping minutes of such meetings;
 - 11) delegate part of their powers to another employee of the Federation;
 - 12) organize the implementation of the decisions of the Conference;
- 13) make decisions on acceptance, termination or exclusion from the membership of the Federation;
 - 14) determine the main and specific areas of activity of the Federation;
 - 15) announce the priorities of the Conference;
 - 16) to develop programs of activity of the Federation;
- 17) make decisions on issues that are not referred to the exclusive powers of other bodies of the Federation;
- 18) to approve the Republican calendar plans for the organization of sports and recreational and sports events of the Triathlon Federation;

- 19) in agreement with the Chairman of the Federation, submit candidates for head and state coaches, head coaches among youth to the relevant bodies;
- 20) consider and resolve issues related to the activities of the territorial divisions (representative offices) of the Federation;
- 21) coordinate the provisions, rules, regulations and similar acts on triathlon adopted by the Conference and mandatory in the Federation system, including the activities of territorial divisions;
- 22) implement approved programs for the development of triathlon, develop and implement activities aimed at implementing the decisions of the governing bodies;
- 23) approve the rules, regulations and other documents of the Federation, determine the system of control over their implementation, including determine the system of sanctions and restrictions in relation to its members;
 - 24) approve the procedure and frequency of holding official sports events of the Federation;
- 25) approve regulations on inter-regional, national and international official competitions and other sporting events;
- 26) make internal decisions on the formation, approval and implementation of programs for the retraining of athletes, advanced training of judges, coaches and other triathlon specialists in the Federation system;
- 27) together with the Ministry of Physical Culture and Sports of the Republic of Uzbekistan, to promote the formation of the composition of coaches for the preparation of national teams of the Republic of Uzbekistan, scientific and medical workers, other specialists, including foreign citizens and stateless persons, to participate in international official sports events in triathlon;
 - 28) to appoint and dismiss the first heads of the territorial subdivisions of the Federation;
- 29) submit candidates to the relevant authorities for the formation of the composition of the national triathlon team;
- 30) give proposals on the evaluation of the performances of the national teams of the Republic of Uzbekistan at triathlon competitions, the activities of coaches, specialists and other persons, encouragement, including bonuses based on results, as well as the application of disciplinary or other penalties;
- 31) to promote the approval of the criteria for the selection of athletes for inclusion in the national triathlon team of the Republic of Uzbekistan, including for participation in the Olympic Games;
- 32) to form commissions and other ad hoc working groups provided for in these statutes, to facilitate the hearing and decision on cases of violations by members of the national federation, members of national teams, coaches and other persons of anti-doping, disciplinary and other rules for triathlon;
- 33) make decisions on the provision of charitable or material assistance to legal entities and individuals within the framework of the subject and goals of the activities of the national federation;
 - 34) define a list of confidential information;
 - 35) approve the staffing and organizational structure of the Federation;
- 36) make decisions on issues related to the rights and obligations of organizations included in the structure of the Federation;
- 37) make decisions on the creation and liquidation of territorial subdivisions of the Federation;
 - 38) approve regulations on the territorial subdivisions of the Federation;
 - 39) approve the budget of the Federation and dispose of the property of the Federation;

- 40) approve the emblem, make changes and additions;
- 41) develop and implement annual work plans based on the strategy plan of the Federation, etc.

5. SOURCES FOR THE FORMATION OF CASH AND OTHER PROPERTY OF THE FEDERATION, RIGHTS OF THE FEDERATION AND ITS STRUCTURAL SUBDIVISIONS (BRANCHES AND REPRESENTATIVE OFFICES) ON PROPERTY MANAGEMENT

- 5.1. The sources of formation of financial resources and other property of the Federation in accordance with the current legislation are:
- 1) voluntary property contributions, sponsorship and charitable assistance, membership fees;
- 2) other means not prohibited by law (from holding lectures, sporting events provided for by the charter);
 - 3) other income not prohibited by law.
- 5.2. The rights of the Federation and its structural divisions for property management, the procedure for receipt of contributions paid by members and other funds are determined by this Charter and decisions of the Secretary General of the Federation.
- 5.3. The Federation carries out its financial and economic activities in accordance with the legislation of the Republic of Uzbekistan.
- 5.4. The federation may have buildings, structures, housing, vehicles, equipment, sports equipment and technical means necessary for the material support of the statutory activities.
- 5.5. The Federation is the sole owner of the property. The procedure for transferring or giving permission for the use of property and funds is determined by the legislation of the Republic of Uzbekistan.
- 5.6. Profit from the industrial, economic and other activities of the Federation, as well as sponsorship funds, cannot be distributed among the members of the Federation as profit, it is directed only to the fulfillment of statutory tasks.
- 5.7. The Federation bears full responsibility for the activities of its structural subdivisions, their actions must be carried out in agreement with the authorized governing body. Territorial subdivisions use the property endowed by the Federation without the right to alienate it.
- 5.8. The state is not responsible for the activities of the Federation. The Federation is not responsible for the activities of the state.
 - 5.9. The structure of the Federation includes its territorial divisions.

Subdivisions that have the status of a legal entity are subject to state registration with the territorial bodies of justice, subdivisions that do not have the status of a legal entity are subject to registration with the territorial bodies of justice.

The governing bodies of the territorial subdivisions are the general meetings of the subdivisions.

The General Assembly, which is the governing body of the division, consists of members of the Federation located in the territory where the activities of the relevant division are carried out.

The general meeting of the division is convened by the governing bodies or the head of the division of the Federation at least once a year, his powers include the election of delegates to the Conference and the exercise of other powers.

Subdivisions have the right to have property in accordance with the legislation, as well as to realize the goals and objectives of the Federation and have other rights in accordance with the legislation of the relevant territory.

Subdivisions are obliged to comply with the law, implement the decisions of the governing bodies of the Federation, and also bear other obligations.

The procedure for the creation, reorganization and liquidation of a subdivision, its rights and obligations, the rights to manage property, its governing bodies are determined by the regulation on the subdivision.

5.10. The property of subdivisions and other structural subdivisions of the Uzbekistan Triathlon Federation is the property of the Uzbekistan Triathlon Federation, and is subject to disposal as the property of the Uzbekistan Triathlon Federation.

6. PROCEDURE FOR MAKING CHANGES AND ADDITIONS TO THE CHARTER OF THE FEDERATION

- 6.1. Changes and additions to this charter are made by decision of the Conference of the Federation.
- 6.2. In cases stipulated by the legislation of the Republic of Uzbekistan, changes and additions are subject to state registration in the prescribed manner.

7. PROCEDURE FOR REORGANIZATION AND LIQUIDATION OF THE FEDERATION. DISPOSAL OF THE PROPERTY OF THE FEDERATION IN ITS LIQUIDATION

- 7.1. Liquidation or reorganization of the Federation is carried out in accordance with the law.
- 7.2. The Federation may be liquidated or reorganized by decision of the Conference or by judicial procedure.
- 7.3. After the liquidation of the Federation, its property is directed to the purposes and tasks stipulated by the charter of the Federation.

8. FINAL PROVISIONS

8.1. This Charter comes into force after its state registration with the Ministry of Justice of the Republic of Uzbekistan.
